But I'm sure you already knew all that, and since this is the Control Room and not the Presidents Pity Party, I'll move on to news relevant to the BRMA... of which there is sadly very little. Perhaps not surprisingly, not much has happened since my last The Hanford site remains on limited operations, Benton and Franklin Counties are a COVID-19 hotspot in Washington State and remain in Phase 1 of the "Stay Home, Stay Healthy" directive here in Washington. The Manhattan Project National Historical Park, Hanford Unit, (MAPR Hanford) is currently not conducting tours. There will likely be no tour season this year, which also means no visitors, and no sales in the gift shop. Rick Bond, our products and sales guy, did a lot of work in the gift shop in the off-season and it looks like the public will have to wait a little longer to see the results of his hard work.

Later in August we will observe the 75th anniversary of the bombings of Hiroshima and Nagasaki, and

World Citizens for Peace will conduct their bell-ringing ceremony on August 9th at Howard Amon Park, and the National Park Service is working on connecting with audiences through mostly online events. Speaking of the NPS, our ranger Becky recently hired a few temporary staff members to help her with some of the projects the NPS is working on, including development of the Manhattan Project National Historical Park mobile application, or "app", in addition to other interpretive projects. The BRMA is making its first venture into this new age by having our first Board Meeting through Zoom on July 3rd. Online meetings and social media may be the new normal for a whole, or maybe permanently. I think that we, as an organization, need to think about how we can reach the public outside of the tour program and in-person visits to the reactor.
